Terms and Conditions:

1. Applicant warrants that the insurance coverage noted on this Application will be maintained until the Expiry Date for the Restricted Area Vehicle Pass.
2. Vehicle may only be operated in those areas noted under “Area of Operation” on this Application. A vehicle found in an unauthorized area will have the Restricted Area Vehicle Pass confiscated and the registered owner may have all vehicle pass privileges permanently revoked.
3. A vehicle requiring an “escort” found operating airside without an authorized escort will be directed to immediately leave airside. The Restricted Area Vehicle Pass will be confiscated and the registered owner will have all vehicle pass privileges revoked.
4. Applicant warrants that the vehicle will be operated in accordance with the “YVR Airside Traffic Directives” at all times while operating airside.
5. Applicant must notify the Access Control Office immediately on discovery of a lost or stolen Restricted Area Vehicle Pass.
6. A Restricted Area Vehicle Pass is issued and valid only for the vehicle noted on this Application and must be permanently affixed to the driver’s side windshield. Vehicles under a “Block Pass” are exempted from this condition.
7. This vehicle may only be driven airside in the course of official company business. Misuse of the Restricted Area Vehicle Pass or breach of the “YVR Airside Traffic Directives” may result in a suspension of the pass.
8. The Restricted Area Vehicle Pass issued to Applicant is not transferable and remains the property of the Vancouver Airport Authority. Vancouver Airport Authority reserves the right to demand surrender of the Restricted Area Vehicle Pass from Applicant at any time.
9. You may park airside only in :
 - a) your leased / licensed area.
 - b) inside Apron safety lines & staging areas one hour prior to the scheduled flight, at the appropriate gate, you are servicing.
 - c) in your reserved parking stall.
 - d) in an area as directed by the Vancouver Airport Authority, Airside Operations.
