1.0 Introductions and Welcome

Marion Town welcomed the committee and announced that Michael O'Brien has retired from the Airport Authority. Don Ehrenholz is the new Vice President responsible for Environment and he adds this to his existing role of Vice President for Engineering.

2.0 Review of Minutes from April 23, 2015 Meeting

Simon apologized for the delay issuing minutes from the April 23, 2015 meeting. The minutes have been drafted and will be circulated for review. The following action items have been carried forward from the April 23 meeting:

- Action 1: Discuss Earthquake risks and preparedness at a future meeting. This will be scheduled for a future meeting.
- Action 2: YVR to distribute final Airspace Change Communication & Consultation Protocol to the committee when it is available.

3.0 YVR Environmental Management Plan Priorities Updates

a) Reduce Greenhouse Gas Emissions

- Electric vehicles/EV charging

Marion mentioned that YVR has recently acquired two new electric vehicles that will be added to the Airport Authority's fleet. She noted that the airport has installed several new electric vehicle charging stations and is planning for more next year. Marion also reminded the committee that YVR is working on a plan for a District Energy system.

b) Reduce Waste

- Waste Wars

Amanda Chow gave a presentation on the recent waste reduction campaign titled Waste Wars. Waste Wars was a friendly competition to encourage food and beverage tenants in the terminal to sort their waste and avoid contamination in their garbage and compost/recycling bins. The program ran for July and August and provided education and incentives for proper waste handling and sorting. A total of 48 tenants participated and over 1400 toters of compost were collected. An awards presentation was held on October 13th with first place going to Fortune Wok, second place was Vino Volo (Transborder) and third place was A&W (DTB). The program was a huge success and will be considered for rollout again next year. A committee member asked where the compost material is taken. Compost from the Terminal is sent to Harvest Power in Richmond.

c) Reduce Potable Water Use

- Summer water restrictions

Marion explained some of the water conservation measures taken by YVR during this summer's dry weather and the water restrictions set by Metro Vancouver and City of Richmond. Some examples of water conservation measures at the airport include shutting off all irrigation systems and water features like the International Terminal salmon stream. A brief discussion followed. It was suggested that Metro Vancouver could be invited to a future meeting to share some of their lessons learned during the dry summer and other plans for water conservation.

Action 3: Invite Metro Vancouver to a future meeting to present on water conservation.

d) Improve Ecosystem Health

- YVR Glycol Management

Oge Anoliefoh presented an overview of the YVR Water Quality monitoring program with a focus on aircraft de-icing, glycol management and water quality monitoring. Glycol is the main ingredient in aircraft de-icing fluid. The airport has a comprehensive program in place to contain and collect de-icing fluids to prevent them from running off into the Fraser River. The containment measures include dedicated de-icing pads and storage lagoons as well as vacuum trucks capable of recovering fluids from the ground. The Airport Authority conducts a water sampling program to ensure that glycol containment measures are effective. During the previous winter season of October 2014 - March 2015 over 198 water samples were collected from airport ditches and tested for glycol. One of the samples exceeded the glycol guidelines limit of 100 mg/L. Due to time constraints questions and comments were asked during the coffee break.

- Salmon-Safe

Marion provided a brief status on the Salmon-Safe initiative. YVR continues to work with Salmon-Safe and Fraser Basin Council with the intent of pursuing certification under the Salmon-Safe program.

4.0 Master Plan Consultations

Jenny Duncan and Meg Comiskey presented a preliminary review of this summers' Master Plan community engagement and stakeholder consultations. This initial round of consultations took place between May and September and asked people about their vision of the future for the airport. The public was directed to the website YVR2057.ca for information and were encouraged to complete a survey to help gather input. YVR visited more than 70 events and festivals across British Columbia. More than 2000 people complete the survey. Results of the survey are being summarized in a report that will be posted on airports website. This was the first phase of several rounds of meetings and consultations. Future consultations will focus on proposed airport development projects and related issues.

5.0 South Airfield Runway End Safety Areas Update

Simon Robinson provided an update on the RESA construction program including work completed in 2015 and the current schedule for 2016 and 2017. He mentioned that the 2015 runway closure period was affected by the Taxiway Delta emergency repairs which involved a complete resurfacing of the taxiway. Due to the taxiway repairs use of the north runway at night extended beyond the August 31st schedule and continued until September 19th.

In 2016 construction will continue on RESA 26L and the north runway will be used at night from May until the end of August. The previously scheduled work on the crosswind runway RESA's has been postponed and will not take place in 2016. There was a question about the schedule for the North Runway RESAs. Simon said that there were no current plans to being work on the North Runway RESAs and that planning was at least two years off.

7.0 VAFFC Fuel Delivery Project Update

Adrian Pollard from FSM provided an informative and detailed update on the Vancouver Airport Fuel Delivery Project. The project will need to obtain an amendment to the BC Environmental Assessment certificate due to routing changes and a proposed pipeline diameter increase from 300mm to 350mm. Adrian pointed out that the larger pipeline diameter is intended to improve energy efficiency of pumping and is not meant to increase the overall system capacity. The project is in active discussions with regulators to obtain permits including from Port Metro Vancouver, BC Oil and Gas Commission, City of Richmond and YVR. Adrian mentioned that two public information sessions were held recently, one on August 27th and another on September 17th, as part of the requirements from the Port Metro Vancouver permit application. A summary of the consultation and comments will be posted on the project website (vancouverairportfuel.ca) and Port Metro Vancouver's website (portmetrovancouver.com).
